**General Rules and Regulations:**

- Vendors must check in at the office and be escorted to their assigned space.
- Vendors may check-in on Wed. from noon – 6pm & Thurs. from 9am – 6pm. Spaces are assigned on a first come first serve basis, as payment is received. **No space will be reserved unless paid in full.**
- All vendors must be off the grounds by 6pm Sunday of show.
- The buildings will be open from 9:00 am to 9:00 pm on Friday and Saturday, 9:00 am to 3:00 pm on Sunday. Times are subject to change.
- Foul, abusive language, obscene or X-rated material will not be tolerated.
- Selling knives, guns, etc. to people under the age of **18** is **PROHIBITED**.
- Vendors are responsible for providing their own tables, chairs, and display units. Tables are available on a limited basis for indoor vendors.
- Vendors are responsible to clean up the area before leaving the grounds. Please break down any cardboard boxes before throwing them in the *dumpsters* (not garbage cans) along with the rest of your trash.
- Alcoholic beverages, drugs and drug paraphernalia are **PROHIBITED**.
- Unauthorized vehicles driving around the show grounds are **PROHIBITED**.
- No animals, skateboards, or bicycles are permitted on the grounds during the show. **NO EXCEPTIONS!**
- The F.A.R.M. Club reserves the right to accept or reject any vendor. All decisions by the Club are final.

Failure to comply with any of the above requirements may result in your being asked to leave, and/or not being invited back to future shows and your money will not be refunded.
